Excess Units for the Quarter

If you're considering enrolling in excess units to meet your academic goals or unique circumstances, you will need to review your **eligibility** and may need to submit an **Excess Study List Units Petition**. Below are answers to common questions about the process:

Am I Eligible for Excess Units?

- To be eligible for excess units (exceeding 19 units in regular fall, winter, or spring quarters, or 18 units in summer), you must meet ALL of the following conditions:
 - 1. Be in good academic standing
 - 2. Have a cumulative GPA = 3.0
 - 3. Have earned a GPA of = 3.0 in at least 15 units during the last quarter completed
- Note: if you do not have an established UC GPA (i.e., first quarter at UCLA), you are not eligible for excess units until you have established a UC GPA in a regular quarter (note: Summer is not considered a regular quarter)

How Do I Request Excess Units?

- If all your grades are in for the previous regular quarter and you meet the
 eligibility requirements, you will be automatically approved for 22 units (does
 not apply for summer) once the regular quarter begins
 - If you meet eligibility but would like 23 or 24 units, visit REACH or A316 Murphy Hall Window to speak with an Advisor
- If you do not meet the eligibility criteria, or would like more than 25 units, you
 must submit the Excess Study List Units Petition online

When Do I Submit the Excess Study List Units Petition?

- Submit the petition online in Week 0/1 of the term via your College advising unit
 - For Winter 2025: the petition opens on Wednesday, January 8th at noon
- Petition turn-around time is 3-5 business days
- You can check the status of the petition on MyUCLA to see if it is approved, denied, or requires further information or action
- For regular quarter requests, DO NOT submit the petition until all your grades are posted for the previous quarter or the request will be automatically denied.
- For Summer requests, DO NOT submit the petition until all your grades are posted for the Winter quarter or your request will be automatically denied.
